
1. The **Executive Engineer, Construction Division-3, P.W.D., Etawah** on behalf of Governor of Uttar Pradesh invites the percentage rate bids from the eligible and approved Contractors registered with **UP PWD, in class A ,B,C & D as per G.O. No. 3460/23-7-08-41MSA/54TC III Dated 28.07.2008 as the case may be. The Bidder may submit bids for any or all of the works. Bidders are advised to note the minimum qualification criteria specified in Clause 4 of the Instructions to Bidders to qualify for the award of the contract.**

- 3 Time allowed for completion of work is as mentioned in column no. 7, inclusive of rainy season.
- 4 The bids shall remain valid for acceptance for a period of 90 (ninety) days from the last date of submission of bids. Bids once submitted cannot be withdrawn.
- 5 E-tendering is to be adopted for this tender. Bidding documents can be downloaded from or uploaded to web site <http://etender.up.nic.in>.
- 6 It is compulsory to submit online as-well-as physically a bank draft from any Nationalized bank of amount as given in column 5 of Table, which is to be in favour of Superintending Engineer, Etawah Circle, P.W.D., Etawah.
- 7 Bids must be submitted online (Uploaded) from **12:00 NOON on 28-01-18 to 09-02-18** (up to 12.00 Noon) and the Technical Bids will be opened online on **12.02.18 at 03:00 pm** . If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened online on the next working day respectively, at the same time and validity of bid will be considered from the original date. The date and time of opening of the Financial Bid shall be notified on website. The Financial bids shall be opened online accordingly.
- 8 Bids must be accompanied with security deposit of the amount specified for the work in column 5 of the Table. Bid security will have to be in any one of the forms mentioned in the Bid Document, issued in favour of **EXECUTIVE ENGINEER, CONSTRUCTION DIVISION-3, PWD, ETAWAH** and has validity up to six Months beyond the validity of the Bid.
- 9 A pre-bid meeting will be held for the work on **29.01.18 at 12.00 Noon at the OFFICE OF EXECUTIVE ENGINEER, CONSTRUCTION DIVISION-3, PWD, ETAWAH** to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in Clause 9.2 of "Instructions to Bidders" of the bidding document.
- 10 A bidder shall not be permitted to bid for works responsible for award and execution of contracts in which his or his spouse's near relatives (defined as first blood relations, and their spouses) is posted as Divisional Accountant or as an officer in any capacity between the grade of Superintending Engineer and Junior Engineer (both inclusive). The Bidder has to produce an affidavit quoting the name and post of the person concerned who is working in the concerning Division / Circle of P.W.D., Etawah.
- 11 No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the State / Central Government is allowed to work as a contractor for a period of two years after his retirement from Government service, without Government permission. This contract is liable to be cancelled if either the contractor or any of his employees is found at any time to be such a person who had not obtained the permission of the Government as aforesaid before submission of the tender or engagement in the contractor's service.
- 12 Bid documents and other details consisting of qualification information and eligibility criterion of bidders, plans,

specifications, drawings, the schedule of quantities of the various classes of work to be done and the set of terms & conditions of contract to be complied with by the contractor will be available on the website from **28-01-18** and the same can be seen in the office of the Executive Engineer, Construction DIVISION-3, P.W.D., Etawah between hours 11.00 am and 04.00 pm on any working day between **28-01-18 to 09-02-18** (During Working Hour).

- 13 Any bidder who is having criminal record is not allowed to participate in the bidding process.
- 14 Any bidder who is registered with the state Bar Council is not allowed to participate in the bidding process.
- 15 As per G.O. No. 6738/23-7-2006-176 (Gen.)/06 Dated 05.01.2007 the N.I.T. has been approved in English, but later on as per Government instructions, The Director Information and Public relation has desired N.I.T. in Hindi also. This office has translated the N.I.T. in Hindi. If there is any difference found between English and Hindi formats, the English format shall prevail.
- 16 All information should be submitted by each bidder on prescribed proforma (T-4, T-5, T-6) will be compulsory.
- 17 In case of D.B.M./B.M./B.C./S.D.B.C./Concrete works, only those contractors are eligible to participate in the process, who is owing the respective Hot Mix Plant/Batch Mix Plant/ R.M.C. Plant. Bid security deposit and the Bank Draft should be compulsorily deposited in the Office of **EXECUTIVE ENGINEER, CONSTRUCTION DIVISION-3, PWD, ETAWAH upto 12.00 Noon on 12-02-18.**
- 18 Tender will be accepted as per provisions given in Go. 622/23-12-2012-2/AUDIT/08 TC - 2 dt. 08-06-12 and as per Engineer-in-Chief's Letter No - 379C.G./M.ACC.Public Account Committee/12-13 dt 29-06-2012.
- 19 The undersigned has the right to reject any bid or all the bids without giving any reason for which any claim of the Contractor firm shall not be entertained.
